4. **Angels Park:** Tom Nichols reported fountains are in at Meyers Lake. Geese problem seems to be under control. Grass is filling in. Diffusers should be installed in next few weeks.
5. **Camp Fee collector:** Total fees collected to this date: \$72,656.90
6. **Natel:** Discussion on wiring issues related to Natel's receivers at campground. Park Board waiting to see if Natel fixes problem.

**Discussion on Campground related Items:**
