A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EVANSDALE, IOWA, APPROVING THE MAX LEVY BUDGET HEARING FOR FISCAL YEAR ENDING JUNE 30, 2022

WHEREAS, the City Council of the City of Evansdale have considered the proposed FY2022 city maximum property tax dollars for the affected levy total, and

WHEREAS, a notice concerning the proposed city maximum property tax dollars was published as required and posted on city web site and/or social media accounts if applicable, and


WHEREAS, a public hearing concerning the proposed city maximum property tax dollars was held on March 2, 2021, and

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Evansdale that the maximum property tax dollars for the affected tax levies for FY2022 shall not exceed the following total:

Total maximum levy for affected property tax levies - \$1,008,079 with a levy rate of 7.94876

The Maximum Property Tax dollars requested in the total maximum levy for affected property tax levies for FY2021 does not represent greater than 102% of the Maximum Property Tax dollars requested for the current FY2022 levy.
